## Rules made under Section 52(4).

In exercise of the powers vested in him by section $52(4)$ of the Poiice Law, 1958, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following rules :-
I. These Rules may be cited as the Cyprus Senior Police Officers' Association Rules, 1958, and shall come into force on the first day of May, 1958.
2. In these Rules, unless the context otherwise requires -
"Assistant Superintendent of Police" includes a temporary Assistant Superintendent of Police but does not include an Acting Assistant Superintendent of Police.
3. There is hereby established an association to be called the Cyprus Senior Police Officers' Association (in these rules referred to as "the Association '").
4. Police Officers for the time being of the ranks of Chief Superintendent, Superintendent and Assistant Superintendent shall be members of the Association :

Provided that this rule shall not apply to a police officer who, within one month of the making of these rules or within one month of his qualifying to become a member of the Association, gives notice in writing to the Secretary of the Association of his intention not to become a member of the Association :

Provided further that any member of the Association may resign therefrom by notifying in writing the Secretary of the Association of his desire to do so :

Provided further that a police officer who has resigned from the Association may, if he is eligible, at any time rejoin the Association by notifying the Secretary of the Association of his desire to do so.
5. The affairs of the Association shall be managed by a Committee.
6.- (a) The Committee shall consist of an elected representative from each of the following Divisions and Units :-

Headquarters, Nicosia, Limassol, Famagusta, Larnaca, Paphos,
Lefka, Kyrenia, Troodos, Fire Service Headquarters, Mobile Reserve
Headquarters, Port and Marine Headquarters.
(b) Members of the specialist departments (Mobile Reserve, Fire Service, Criminal Investigation Department, Special Branch, etc.) will be eligible for election in the Division to which they are attached.
(c) The election of representatives will be by secret ballot, from nominated candidates who have been properly proposed and seconded.
7. The Committee shall meet twice a year in March and September, the March meeting being immediately before the Annual General Meeting:

Provided that additional meetings may be held with the approval of the Chief Constable.
8.-(a) Divisional and Unit Meetings may be held from time to time, with the approval of the Divisional or Unit Commander, upon application by the Divisional Representative.
(b) All members of the Association may attend the Divisional Meetings of the Division or Unit in which they are serving, subject to the exigencies of the service.
9. The Association shall hold an Annual General Meeting in March of each year, which all members of the Association may attend, subject so the exigencies of the service.

IO.-(I) The Officers of the Committee shall comprise the Chairman who shall be elected by the Committee from those members of the senior rank serving on the Committee, a Vice Chairman and a Secretary who shall be elected by the Committee from their number.
(2) A Treasurer may be elected and this Officer may be co-opted to serve :

- Provided that if he is a co-opted member he shall only have power to vote on matters directly connected with his office as Treasurer.
II. The representatives elected to serve on the Committee shall assume office immediately following the Association's Annual General Meeting.

I2.-(a) Members attending Divisional or Unit Meetings shall do so at their own expense.
(b) The Annual General Meetings, the Committee or Divisional or Uni ${ }^{2}$. Meetings shall not be open to members of the public or Press.
(c) The Committee shall have the authority to pass resolutions for submission to the Secretary of State for the Colonics or Government, through the Chief Constable, or to the Chief Constable.
(d) Divisional or Unit Mee.ings may pass resolutions for submission to the Committee or to the respective Divisional or Unit Commander.
(e) The Chairman of the Committee may have a second or casting vote.
( $f$ ) No Meeting shall last for more than one day, except with the approval of the Chief Constable.
( $g$ ) The Associa'ion's Annual General Meeting shall for the purposes of the payment of aliowances and expenses be deemed to be an occasion of police duty.
( $h$ ) The attendance at a Committee Meeting shall be deemed to be a police duty, but no expenses for subsistence shall be payable by the Government.
13.-(a) The Association may raise funds by subscriptions among its members, and may collect subscriptions from its members to meet its expenses. Donations shall only be accepted from members of the Association.
(b) The Committee shall fix the amount of subscriptions payable by the members at the Annual General Meeting.
(c) The Committee shall keep detailed accounts of any subscriptions or donations paid to it and shall have them audited by an independent auditor. An annual Statement of Accounts shall be available at the Annual General Meeting. The Governor or the Chief Constable may at any time call for a copy of such Statements of Account or any books kept in connection with the affairs of the Association.
(d) The funds of the Association shall not he used for contributing directly or indirectly to
(i) the funds of a trade union;
(ii) the funds of a political party;
(iii) the election expenses of a candidate for any election outside the Force ;
(iv) the funds of any body or organisation outside the Force ;
(v) benevolent or charitable expenses except with the express approval of the Governor ;
(vi) to defray any expenses incurred by or on behalf of any member of the Force in respect of any criminal or disciplinary proceedings against him.
(e) The funds of the Association may be used-
(i) to pay expenses incurred in connection with Meetings of the Association ;
(ii) to pay expenses incurred by representatives in attending Meetings of the Association Committee which are not chargeable to public funds;
(iii) for such other purposes as the Chief Constable may approve.

## Rules made under Section 52 (4).

In exercise of the powers vested in him by section 52 (4) of the Police Law, 1958; His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following rules:-

1. These Rules may be cited as the Cyprus Police Association Rules, 1958, and shall come into force on the first day of May, 1958.
2. The Cyprus Police Association (in these Rules referred to as "the Association ") shall consist of all members for the time being of the Force below the rank of Assistant Superintendent and the Association shall act through the committees as hereinafter provided.
3. There shall be constituted three committees, one for Constables, one for Sergeants and one for Inspectors, to be called the "Constables' Committee", the "Sergeants' Committee" and the "Inspectors' Committee", respectively.
4. The Committee shall consist of one member for each Division elected by members of the Force for the rank in question belonging to that Division. For the purposes of these Rules the following shall be deemed to constitute the Divisions:-
(a) Nicosia, Limassol, Famagusta, Larnaca, Paphos, Kyrenia, Lefka and Troodos Divisions;
(b) Headquarters Division (including Headquarters Departments and Training School) ;
(c) Mobile Reserve Division (including Mobile Reserve Headquarters and Mobile Reserve Units stationed at Nicosia) ;
(d) Port and Marine Division (including Port and Marine Headquarters, Famagusta) ;
(e) Fire Service (including all fire service units throughout the Colony) :
Provided that save as provided in paragraph (c) of this rule members of the specialist departments (Mobile Reserve, Criminal Investigation Department, Special Branch, etc.) shall be eligible for election in the Division to which they are attached.
5. All Police Officers of each rank shall have the right to vote at an election of the committee for that rank prome ofac

Provided that any police officer attached to any Division who at the time of the election is at the Police Training School or temporarily transferred away from his Division shall vote for his Divisional candidate and
