In exercise of the powers vested in me by section 78 of the Courts of Justice Laws, 1953 to 1958, I, the Governor, with the advice and assistance of the Chief Justice, do hereby make the following Rules :---

1. These Rules may be cited as the Civil Procedure Rules (No. 1), 1958, and shall be read as one with the Civil Procedure Rules (hereinafter referred to as "the principal Rules").

2. Order 8 Rule 1 of the principal Rules is hereby amended as follows :---

- (a) by the substitution of "£50" for "£10" in the first line of paragraph (i) thereof; and
- (b) by the substitution of "£2" for "10s." in the second line of paragraph (ii) thereof.

3. Order 8 Rule 2 is amended by the addition thereto of the following as sub-rule (3) :=

"(3) No Court fees shall be payable on filing any such application or in respect of the affidavit accompanying it."
