## CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

#### NOTICE UNDER SECTION 6.

With reference to Notification No. 1036 published in Supplement No. 3 to the *Gazette* of the 1st November, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :---

All those areas of privately owned lands, with everything standing thereon, situated at Aradhippou village, comprising 4 donums, 2 evleks or thereabouts, forming parts of plots Nos. 117, 119, 118, 113, 112, 270, 269/2, 269/1, 297, 297/1, 296, 295, 292, 289, 384/1, 384/2, 388/1 and 387 of the Government Survey Plan No. XL.46 and parts of plots Nos. 561/2 & 561/1 of the Government Survey Plan No. XL.47, more particularly defined as the areas coloured red on the plan signed by the Director of Public Works and dated the 24th April, 1958.

### THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955.

#### ORDER MADE UNDER REGULATION 38.

I, the Assistant Commissioner of Lefka, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955, do hereby order as follows :---

1. This Order may be cited as the Protected Area (Lefka No. 1 of 1958) Order, 1958.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955.

3. This Order shall come into force at 1200 hours on 23rd April, 1958, and shall remain in force until further notice, unless revoked or extended by a supplementary order under my hand.

#### SCHEDULE.

The area lying within plots Nos. 2 and 204 in block H of the Xeros quarter of Karavostasi which is within a radius of 10 yards from the perimeter of the Electricity Authority's Sub-station situated thereon.
