THE CEMENT INDUSTRY (ENCOURAGEMENT AND  
CONTROL) LAW, 1952.

NOTICE UNDER SECTION 9 (2).

Whereas the Cyprus Cement Company Limited, a company registered in Cyprus and having its registered office at Moni, in Limassol District (hereinafter referred to as "the Licensees") are the holders of a licence dated the 17th August, 1953, granted under section 3 of the Cement Industry (Encouragement and Control) Law, 1952 (hereinafter referred to as "the Law") ;

And whereas a notice of the grant of the said licence to the Licensees was published under section 4 of the Law in Supplement No. 3 to the *Gazette* of the 3rd September, 1953 ;

And whereas the owners of the private land, the particulars of which are set out in the Schedule hereto (hereinafter referred to as "the land"), on which quarrying operations are to be carried out by the Licensees, refuse to sell the land to the Licensees ;

And whereas the Licensees have referred the matter to the Governor under sub-section (2) of section 9 of the Law ;

And whereas the Governor is satisfied that it is in the public interest that the quarrying operations proposed to be carried out on the land by the Licensees should be undertaken and that failure to acquire the land will seriously impede or prevent such operations :

Now, therefore, in exercise of the powers vested in him by sub-section (2) of section 9 of the Law, His Excellency the Governor has been pleased to sanction the acquisition of the land under the provisions of the Law.

Plot No. 229 of the Government Survey Plan No. LIV. 46 field, 1 evlek, 3,500 square feet, registered in the names of Priamos Antoniou Frangos of Ktima, Emilios, Nicos, Michalakos and Christoforos Antoniou Frangos of Limassol and Koulla Antoniou Frangou of Nicosia under Registration No. 7872 of Ayios Tykhonas.
