ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1957, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Kyrenia District No. 2) Order, 1958.

2. No person within the municipal boundaries of Kyrenia town shall be out of doors between the hours of 7.30 p.m. and 4.30 a.m. except under the authority of a written permit granted by the Assistant Commissioner of Kyrenia or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.
