

And whereas His Excellency the Governor by Notification No. 124 published in Supplement No. 3 to the *Gazette* of the 23rd February, 1956, declared the widening, improving and realigning of the public road between Famagusta and Larnaca to be an undertaking of public utility ;

And whereas portions of the acquired lands, the particulars whereof are set out in the Schedule hereto, are required for the widening, improving and realigning of the public road between Famagusta and Larnaca, an undertaking of public utility, in respect of which the above mentioned Notification has been published in the *Gazette* under the provisions of the Land Acquisition Law :

Now, therefore, it is hereby notified that the lands, the particulars whereof are set out in the Schedule hereto will, under the provisions of sub-section (1) of section 19 of the Land Acquisition Law, be retained for the purposes of the widening, improving and realigning of the public road between Famagusta and Larnaca.

SCHEDULE.

All those areas of land situated at Akhyritou village, comprising 2 evleks and 3,400 square feet or thereabouts and including parts of plots Nos. 72 and 252 of the Government Survey Plan No. XXXIII.26, more particularly defined as the areas coloured green on the plan signed by the Director of Public Works and dated the 30th July, 1957, and deposited in the office of the Commissioner, Famagusta.
