**THE ANTIQUITIES LAW.**  
**CAP. 43.**

**NOTICE UNDER SECTION 11.**

In exercise of the powers vested in him by section 11 of the Antiquities Law, Cap. 43, His Excellency the Governor has been pleased to order as follows :—

From and after the date of the publication of this notice in the *Gazette* no building shall be erected, reconstructed or repaired and no tree shall be felled within the area adjacent to an ancient monument to wit the site and remains of Salamis, comprising the areas of land specified in the Schedule hereto, save in accordance with the terms of a permit in writing from the Commissioner previously obtained.

**SCHEDULE.**

All those areas of land situated at Ayios Seryios village in Famagusta District, comprising 20 donums or thereabouts, including part of plot No. 35/1 and the whole of plots No. 34, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 57, 58, 59, 60, 61, 62, 63, 65 and 66 of the Government Survey Plan No. XXIV.35, more particularly defined as the areas marked "A" and "B" and delineated red on the Government Survey Plan Serial No. 1703, deposited in the office of the Director of Lands and Surveys, at Nicosia.

**THE CURFEWS LAWS, 1955.**  
**LAWS 17 AND 47 OF 1955.**

**ORDER MADE UNDER SECTION 2.**

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District No. 2) Order, 1958, amended.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force, or any servant of a Public Utility, when acting in his official capacity on duty.

This Order shall come into force on the 8th day of June, 1958.

**FIRST SCHEDULE.**

The area of the town of Nicosia lying within the walls of the old city. This Order applies to all residents within the prescribed area, who are required to remain indoors.

**SECOND SCHEDULE.**

This Order comes into force at 00.20 hours on Sunday, 8th June, 1958, and shall remain operative until further notice.
