THE EXCHANGE CONTROL LAWS, 1952 TO 1957.

DIRECTION REGULATING THE USE OF HONG KONG ASSETS IN CYPRUS.

In exercise of the powers vested in him by section 38A of the Exchange Control Laws, 1952 to 1957, His Excellency the Governor hereby gives the following direction :

Except with permission granted by or on behalf of the Financial Secretary, no order given by or on behalf of any person resident in Hong Kong on or after the date of this direction may be carried out, in so far as the order—

- (i) requires the person to whom the order is given to make any payment or to part with any securities ; or
- (ii) requires any change to be made in the persons to whose credit any sum is to be paid or to whose order any securities are to be held.

THE EXCHANGE CONTROL LAWS, 1952 TO 1957.

ORDER MADE UNDER SECTIONS 38 AND 44.

1. This Order may be cited as the Exchange Control (Revocation of Certain Finance Regulations) Order, 1958.

2. The Emergency Powers (Cyprus Defence) (Finance) Regulations, 1940 to 1949, and any Orders made thereunder are hereby revoked without prejudice to anything done or left undone thereunder.

NOTICE UNDER SECTION 6.

With reference to notification No. 466 published in Supplement No. 3 to the *Gazette* of the 7th June, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—
