ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in him by section 2 of the Curfews Laws, 1955, His Excellency the Governor has been pleased to order as

1. This Order may be cited as the Curfews (General) Order, 1958.

2. Subject to the provisions of paragraphs 3 and 4 of this Order no person in the Colony shall be out of doors between 7 p.m. in each evening and 4.30 a.m. on each morning except under the authority of a written permit granted by the Commissioner of the district or the police officer in charge of the area in which such person resides.

3. The following persons are hereby exempted from the provisions of

this Order :-

(a) members of Executive Council;

(b) members of Her Majesty's Forces and members of the Police Force (as defined in the Police Law, 1958) on duty.

4. Persons residing within the built up area of any village or improvement area (as defined in the Village (Administration and Improvement) Areas Law, 1950) are hereby exempted from the provisions of this Order for the purposes of pedestrian movement within the limits of such village or improvement area:

Provided that this exemption shall cease to have effect in any such village or improvement area if an order is made under the Curfews Laws applying a curfew, having effect during the hours specified in paragraph 2,

to such village or improvement area.

5. This Order shall come into force on 20th day of July, 1958, and shall expire on the 17th day of August, 1958.

Subject to the provisions of paragraph 3 of this Order, no person in the whole area of the Colony shall be out of doors from 4.30 a.m. o'clock on the 22nd day of July, 1958, until 4.30 a.m. o'clock on the 24th day of July, 1958, except under the authority of a written permit granted by the Commissioner of the District or the Police Officer in charge of the area in which such person resides.

3. The following persons are hereby exempted from the provisions of this Order :-

(a) members of Executive Council;

(b) members of Her Majesty's Forces and members of the Police Force (as defined in the Police Law, 1958) on duty.

4. This Order shall come into force on 22nd day of July, 1958. 5. The Curfews (General) Order, 1958, is hereby revoked.
