## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District No. 28) Order, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 10th day of July, 1958.

## FIRST SCHEDULE.

The Municipal Area of Nicosia, the Improvement Board Areas of Strovolos, Ayios Dhometios, Kaimakli, Palouriotissa and the Village Areas of Omorphita, Engomi, Eylenja, Trakhonas and Orta Keuy.

## SECOND SCHEDULE.

From 1300 hours on 10th July, 1958, till 0430 hours on 11th July, 1958.

## ORDER MADE UNDER SECTION 2.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 12th day of July, 1958.

The Municipal Area of Nicosia, the Improvement Board Areas of Kaimakli, Palouriotissa, Strovolos, Ayios Dhometios and the Village Areas of Engomi, Trakhonas, Omorphita, Eylenja and Orta Keuy.

From 1820 hours on 12th July, 1958 to 0430 hours on 13th July, 1958.
