THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.

ORDER UNDER REGULATION 38.

I, the Commissioner of Nicosia, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as follows:—

1. This Order may be cited as the Protected Areas (Nicosia District No. 4) Order, 1958.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958.

3. This Order shall come into force at 12.15 hours on the first day of August, 1958, and shall remain in force until further notice.

SCHEDULE.

The area of the old railway station comprising the P.W.D. Workshops, P.W.D. Offices, Government Stores, Apprentices' Training Centre, Commissioner's Yard, Forestry Yard, Water Development Yard and Railway Street from its junction with Kaimakli Street as far as the northernmost point of the Forestry Yard, bounded on the south by the Old Turkish Cemetery, Railway Street, Kaimakli Street; on the east by Omorphita Street; on the north by Arta Street, the block boundary between Ibrahim Pasha quarter Blocks A and 28, as far as the eastern boundary of plot 667, Block A Ibrahim Pasha quarter; thence following the northern and western boundaries of plot 667, back to Railway Street.
