LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1957, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Kyrenia District No. K7) Order, 1958.

2. No person within the rural municipality of Karavas shall be out of doors between the hours of 4.30 a.m. on the 14th July, 1958, and 4.30 a.m. on the 16th July, 1958, except under the authority of a written permit granted by the Assistant Commissioner of Kyrenia or the Superintendent of Police in charge of the area.
