

**No. 615. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Famagusta District, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Famagusta District) Order, 1958.

2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 6th day of August, 1958, no motor vehicle shall be used on any road within the Famagusta District between the hours of 7.00 p.m. and 4.30 a.m. unless the person driving such vehicle is in possession of a permit granted to him by the Commissioner or by the Assistant Chief Constable in charge of the area, and subject to such terms and conditions as may be specified in such permits :

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as :—

- (a) a member of Her Majesty's Forces, or
- (b) a Police Officer.

4. This Order shall come into force on the 6th day of August, 1958.

5. The Emergency Powers (Control of Public Service Motor Vehicle by Night) (No. 2) Order, 1958, is hereby revoked in its application to the Famagusta District.

**No. 616. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Paphos District, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Paphos District) (No. 4) Order, 1958.

2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 6th day of August, 1958, no motor vehicle shall be used on any road within the Paphos District between the hours of 7.00 p.m. and 4.30 a.m. unless the person driving such vehicle is in possession of a

permit granted to him by the Commissioner or by the Superintendent of Police in charge of the area, and subject to such terms and conditions as may be specified in such permit :

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as :—

- (a) a member of Her Majesty's Forces, or
- (b) a Police Officer.

4. This Order shall come into force on the 6th day of August, 1958.

5. The Emergency Powers (Control of Public Service Motor Vehicle by Night) (No. 2) Order, 1958, is hereby revoked in its application to the Paphos District.

**No. 617. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 34.
