

**No. 64.****THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 22nd August, 1956 and published in Supplement No. 3 to the *Gazette* of the 30th August, 1956 under Notification No. 824 (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Kato Lakatamia village, Nicosia District, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 74 and 748 published in Supplement No. 3 to the *Gazettes* of the 31st January, 1957 and 1st August, 1957 respectively, the Order was extended for further periods of six months up to the 21st February, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957, His Excellency the Governor has been pleased to order and hereby orders that the aforesaid authorization for using the land for military purposes subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 22nd February, 1958 and the Order is so extended accordingly.

And whereas by virtue of Notifications Nos. 1165, 73 and 745 published in Supplement No. 3 to the *Gazettes* of the 29th November, 1956, 31st January, 1957 and 1st August, 1957 respectively, the Order was extended for further periods of six months up to the 28th February, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
