(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 24th August, 1956 and published in Supplement No. 3 to the *Gazette* of the 11th October, 1956 under Notification No. 963 (as amended by Notification No. 769 published in Supplement No. 3 to the *Gazette* of 8th August, 1957) (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the Ayia Phyla village, Limassol District, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 74 and 748 published in Supplement No. 3 to the *Gazettes* of the 31st January, 1957 and 1st August, 1957 respectively, the Order was extended for further periods of six months up to the 23rd February, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957, His Excellency the Governor has been pleased to order and hereby orders that the aforesaid authorization for using the land for military purposes subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 24th February, 1958 and the Order is so extended accordingly.

And whereas by virtue of Notifications Nos. 74 and 746 published in Supplement No. 3 to the *Gazettes* of the 31st January, 1957 and 1st August, 1957, respectively, the Order was extended for further periods of six months up to the 16th February, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

AMENDMENT OF ORDER MADE UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor hereby amends the Order made under Defence Regulation 64 and published under Notification No. 773 in Supplement No. 3 to the *Gazette* of the 15th August, 1956 (as extended by Notification No. 748 in Supplement No. 3 to the *Gazette* of the 1st August, 1957) as follows :

- (a) by the deletion of the figure " 1504 " from line ten of the Second Schedule thereto and the substitution therefor of the figure and word " 1504 (part) ", and
- (b) by the deletion of the words " plan signed by the Assistant Director, Hirings, Cyprus, dated the 10th August, 1956 " from lines fifteen and sixteen of the Second Schedule thereto and the substitution therefor of the words " plan signed by the Assistant Director of Lands, Cyprus, dated the 11th January, 1958 ".
