THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1958.

Order made under Regulation 60A.

Whereas I consider it expedient in the interests of Public Safety to make a clearance order in respect of the land described in the Schedule hereto :

Now, therefore, I, the Commissioner of Nicosia, in exercise of the powers vested in me by Regulation 60A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as follows :--

1. This order may be cited as the Emergency Powers (Clearance) (Nicosia District) (No. 1) Order, 1958.

2. The owners and occupiers of the land described in the Schedule hereto (hereinafter referred to as "the land "), and the agents of such owners and occupiers, are hereby directed :---

- (a) to cut and clear away from the land all herbage, bush and undergrowth;
- (b) to prevent any herbage, bush or undergrowth on the land from growing higher than one foot and to maintain the land in a clear condition to the satisfaction of the Area Commander, Nicosia;
- (c) to cut flush with the trunk and clear away the branches of all Cypress trees standing on the land to a height of twelve feet from ground
- level, and of all fruit trees to a height of six feet from ground level; (d) to cut and clear away such Eucalyptus and Acacia trees or branches
 - thereof as may be indicated by the Area Commander, Nicosia.

SCHEDULE.

The area of land abutting on or lying within a distance of fifty yards of the following sections of public roads :---

1. From Nicosia to the District Boundary on the main Nicosia-Lefkoniko road.

2. From Kythrea southwards to Palekythro.

3. From Voni northwards to the main Nicosia-Lefkoniko road.

4. From Nicosia to the District Boundary on the main Nicosia-Larnaca Road at the 16th milestone.

5. From Potamia north-eastwards to the main Nicosia-Larnaca Road at Pyroi.

6. From Louroujina north-eastwards to the main Nicosia-Larnaca Road.

7. From Nicosia to the District Boundary on the main Nicosia-Limassol road.

8. From Nicosia to the 9th Milestone on the main Nicosia-Deftera road.

9. From the 9th Milestone at Pano Deftera southwards to Episkopio. 10. From the 9th Milestone at Pano Deftera westwards to Ayios Ioannis.

11. From Kambia northwards to Psomolophou.

12. From Avlona northwards to Phylia.

13. From Yerolakkos southwards to the main Nicosia-Troodos road. 14. From Yerolakkos westwards to Phylia.

15. From the main Nicosia-Lefkoniko road eastwards along the old Railway Line to the District Boundary.

No. 697. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS 1955 TO (No. 3) 1958.

ORDER MADE UNDER REGULATION 34.

I, the Commissioner of Nicosia, in exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as follows :--

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Nicosia District) (No. 2) Order, 1958.

2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 25th day of August, 1958, no motor vehicle shall be used on any road within the Nicosia District between the hours of 7.00 p.m. and 3.30 a.m. unless the person driving such vehicle is in possession of a permit granted to him by the Commissioner, or by the Assistant Chief Constable in charge of the area, and subject to such terms and conditions as may be specified in such permit:

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as :—

(a) a member of Her Majesty's Forces, or

(b) a Police Officer.

4. This Order shall come into force on the 25th day of August, 1958.

5. The Emergency Powers (Control of Motor Vehicles by Night) (Nicosia District) (No. 1) Order, 1958, is hereby revoked.
