**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 39A.

Whereas I, the Commissioner of the District of Famagusta, am satisfied that the building described in the Schedule hereto (hereinafter referred as "the building") is a building which is being used by terrorists, now, therefore, in exercise of the powers vested in me by Regulation 39A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, with the approval of the Governor, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Forfeiture and Demolition) (Famagusta District) (No. 5) Order, 1958, and shall come into force on the 21st day of August, 1958.
2. It is hereby directed that the building and its contents be forfeited and demolished.

SCHEDULE.

The farm building situated at Patriki village in the district of Famagusta registered under No. 2530 of 1st December, 1942, in the name of Avxentios Christoforou of Patriki and standing on plot 256 of the Government Survey Plan 15/6.

**No. 717. THE EMERGENCY POWERS (PUBLIC SAFETY AND
ORDER) REGULATIONS 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me by Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Paphos District, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Control of Motor Vehicles by Night) (Paphos District) (No. 5) Order, 1958.
2. Notwithstanding anything in any Law or Public Instrument contained, from and after the 25th day of August, 1958, no motor vehicle shall be used on any road within the Paphos District between the hours of 7.00 p.m. and 3.30 a.m. unless the person driving such vehicle is in possession of a permit granted to him by the Commissioner or by the Superintendent of Police in charge of the area, and subject to such terms and conditions as may be specified in such permit :

Provided that this paragraph shall not apply to the use of any motor vehicle within any area set out in the Schedule hereto.

3. Nothing in this Order contained shall apply to any person acting in the course of his duty as :—

- (a) a member of Her Majesty's Forces, or
- (b) a Police Officer.

4. This Order shall come into force on the 25th day of August, 1958.

5. The Emergency Powers (Control of Motor Vehicles by Night) (Paphos District) (No. 4) Order, 1958, published under Notification No. 616 to the *Cyprus Gazette* of 25th August, 1958, is hereby revoked.
