No. 764. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1958.

ORDER MADE UNDER REGULATION 39A.

Whereas I, the Commissioner of the District of Famagusta, am satisfied that the building described in the Schedule hereto (hereinafter referred to as "the building") is a building which is being used by terrorists, now, therefore, in exercise of the powers vested in me by Regulation 39A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, with the approval of the Governor, do hereby order as follows:—

1. This Order may be cited as the Emergency Powers (Forfeiture and Demolition) (Famagusta District) (No. 8) Order, 1958, and shall come into force on the 3rd day of September, 1958.
2. It is hereby directed that the building and its contents be forfeited and demolished.

The building situated at Liopetri village in the District of Famagusta registered under No. 2893 in the name of Panayiotis Kalli of Liopetri and standing on plot 104 of Government Survey Plan No. 42/2 village.

**No. 765. THE CURFEWS LAWS, 1955.
LAWS 17 AND 47 OF 1955.**

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Famagusta District) (No. 1) Order, 1958.
2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 28th day of January, 1958.

From 0930 hours on Tuesday 28th January, 1958, until further notice.
