ORDER MADE UNDER REGULATION 60A.

Whereas I consider it expedient in the interests of public safety to make a Clearance Order in respect of the land described in the Schedule hereto:

Now, therefore, I, the Commissioner of Famagusta, in exercise of the powers vested in me by Regulation 60A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as

1. This Order may be cited as the Emergency Powers (Clearance)

(Famagusta District) (No. 3) Order, 1958.

2. The owners and occupiers of the land described in the Schedule hereto (hereinafter referred to as "the land") and the agents of such owners and occupiers are hereby directed-

(a) to cut and clear away from the land all herbage, bush, bamboo

cane, hedge and undergrowth,
