

- (b) to prevent any herbage, bush, bamboo cane, hedge and undergrowth from growing higher than one foot on the land and to maintain the land in a clean condition to the satisfaction of the Area Commander, Famagusta,
- (c) to cut flush with the trunk and clear away the branches of all trees standing on the land to a height of eight feet from ground level, and
- (d) to cut and clear away every third tree of the row along the public road.

SCHEDULE.

The area under Plot Nos. 13, 13/1, 13/2 in Government Survey Plan under Sheet XXXII.4, within the area of Lyssi village in the District of Famagusta, more particularly defined as the area coloured red on the plan signed by the Commissioner Famagusta and dated the 25th September, 1958.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 60A.

Whereas I consider it expedient in the interests of Public Safety to make a Clearance Order in respect of the land described in the Schedule hereto :

Now, therefore, I, the Commissioner of Paphos, in exercise of the powers vested in me by Regulation 60A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Clearance) (Paphos District) (No. 1) Order, 1958.

2. The owners and occupiers of the land described in the Schedule hereto (hereinafter referred to as "the land"), and the agents of such owners and occupiers, are hereby directed :—

- (a) to cut and clear away from the land all herbage, bush and undergrowth ;
- (b) to prevent any herbage, bush or undergrowth on the land from growing higher than one foot and to maintain the land in a clear condition to the satisfaction of the Area Commander, Paphos ;
- (c) to cut flush with the trunk and clear away the branches of all oak trees standing on the land to a height of twelve feet from ground level, and of all fruit trees to a height of six feet from ground level save as may be exempted by the Area Commander, Paphos.

SCHEDULE.

The area abutting on or lying within a distance of fifty yards of the following sections of public road within the District of Paphos :—

1. The portion of the main Ktima-Polis road which lies between the road leading to Skoulli village and the road leading to Akourdalia village.

2. The portion of the main Ktima-Polis road which lies between culvert No. B/79/1 and the road leading to Yiolou village.
