## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Kyrenia District) (No. 18) Order, 1958.

2. No person within the areas prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Assistant Commissioner of Kyrenia or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 5th day of October, 1958.

Within the village boundaries of Karmi, Trimithi and Ayios Georghios.

## SECOND SCHEDULE.

From 2030 hours on Sunday, 5th October, until 0430 hours on Monday, 6th October, 1958.

## ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Lefka Area) (No. 17) Order, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Assistant Commissioner at Lefka or the Assistant Commissioner of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

3. This Order shall come into force on the 17th day of September, 1958.

Within the village boundaries of Pano and Kato Zodhia.

## SECOND SCHEDULE.

From 1600 hours on 17th September, 1958, to 0930 hours on 18th September, 1958.
