ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 618 published in Supplement No. 3 to the *Gazette* of the 13th October, 1955, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Lefka Sub-District) (No. 18) Order, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Lefka or the Assistant Commissioner of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 5th day of October, 1958.

FIRST SCHEDULE.

Within the village boundaries of Pano and Kato Zodia.

SECOND SCHEDULE.

From 2230 hours on 5th October, 1958, to 0500 hours on 7th October, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Lefka or the Assistant Commissioner of Police in charge of the area:

3. Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

4. And provided that this Order shall not apply to any person who is not a Greek Cypriot male or female born on or after 1st January, 1933, and before 1st January, 1946.

This Order shall come into force on the 7th day of October, 1958.

Within the village boundaries of Kato Zodia.

SECOND SCHEDULE.

From 0500 hours on 7th October, 1958, to 2000 hours on 12th October, 1958.
