

SCHEDULE.

1. Anileridine (1-[2-(p-aminophenyl)-ethyl]-4-phenylpiperidine-4-carboxylic acid ethyl ester), its salts and any preparation, admixture, extract or other substance containing any proportion of anileridine.
2. Etoxidine (1-[2-hydroxyethoxy)-ethyl]-4-phenylpiperidine-4-carboxylic acid ethyl ester), its salts and any preparation, admixture, extract or other substance containing any proportion of etoxidine.
3. Methyl dihydromorphine (6-methyl dihydromorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of methyl dihydromorphine.
4. 1-(3-methyl-4-morpholino-2 : 2-diphenylbutyryl)-pyrrolidine, its salts and any preparation, admixture, extract or other substance containing any proportion of 1-(3-methyl-4-morpholino-2 : 2-diphenylbutyryl)-pyrrolidine.
5. Morpheridine (1-(2-morpholinoethyl)-4-phenylpiperidine-4-carboxylic acid ethyl ester), its salts and any preparation, admixture, extract or other substance containing any proportion of morpheridine.
6. Myrophine (myristyl ester of benzylmorphine), its salts and any preparation, admixture, extract or other substance containing any proportion of myrophine.
7. Oxymorphone (dihydro-14-hydroxymorphinone), its salts and any preparation, admixture, extract or other substance containing any proportion of oxymorphone.
8. Trimeperidine (1 : 2 : 5-trimethyl-4-phenyl-4-propionyloxy-piperidine), its salts and any preparation, admixture, extract or other substance containing any proportion of trimeperidine.
9. The esters (other than the ethyl and isopropyl esters) of 1-methyl-4-phenylpiperidine-4-carboxylic acid, their salts and any preparation, admixture, extract or other substance containing any proportion of the said esters.

No. 846. THE DANGEROUS DRUGS LAW, 1956.

LAW 20 OF 1956.

ORDER IN COUNCIL No. 3041

MADE UNDER SECTION 13 (1).

Whereas by sub-section (1) of section 13 of the Dangerous Drugs Law, 1956, it is provided that it shall not be lawful for any person in Cyprus to trade in or manufacture for the purpose of trade any of the products obtained from any of the phenanthrene alkaloids of opium or from the ecgonine alkaloids of the coca leaf, not being a product which was on the thirteenth day of July, nineteen hundred and thirty-one, being used for medical or scientific purposes, and that the Governor may, if satisfied that any such product is of medical or scientific value, by Order in Council direct that the said sub-section shall cease to apply to that product ;

And whereas the Governor is satisfied that the drugs specified in the Schedule to this Order, being products obtained from morphine, one of the

phenanthrene alkaloids of opium, which were not on the said date being used for medical or scientific purposes, are of medical value :

Now, therefore, in exercise of the powers conferred upon him by sub-section (1) of section 13 of the Dangerous Drugs Law, 1956, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :

1. This Order may be cited as the Dangerous Drugs (Relaxation of Law) Order, 1958.

2. Sub-section (1) of section 13 of the Dangerous Drugs Law, 1956, shall cease to apply to the drugs specified in the Schedule to this Order.

SCHEDULE.

1. Methyldihydromorphine (6-methyldihydromorphine).
2. Myrophine (myristyl ester of benzylmorphine).
3. Oxymorphone (dihydro-14-hydroxymorphinone).

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 44.

Whereas it appears to the Governor to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorise its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in him by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, His Excellency the Governor has been pleased to take possession of the land and, in connection with the taking possession and making use of the land, has been pleased to direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorised to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.
