Notice under Section 7.

Whereas by Notification No. 257 published in Supplement No. 3 to the Gazette of the 17th April, 1958, the Governor declared the establishment of an Air Ministry installation together with such buildings and structures as may be necessary at Lysi village in the District of Famagusta to be an undertaking of public utility;

And whereas the Commissioner of Famagusta, by a notice published under Notification No. 704 in Supplement No. 3 to the *Gazette* of the 11th September, 1958, gave particulars of the lands (hereinafter referred to as the "lands") required in connection with the aforesaid undertaking;

And whereas the Commissioner of Famagusta forwarded to the Governor the required recommendations, plan and particulars, together with the objections made;

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition, under the provisions of the said Law, of the lands.
