ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows:—

1. This Order may be cited as the Curfews (Paphos District) (No. 46) Order, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Paphos or the Superintendent of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 6th day of October, 1958.

FIRST SCHEDULE.

Within the village boundaries of Lyssos.

SECOND SCHEDULE.

From 2000 hours on 6th October, 1958, until 1730 hours on 8th October, 1958.

ORDER MADE UNDER SECTION 2.

1. This Order may be cited as the Curfews (Paphos District) (No. 47) Order, 1958.

2. No Greek Cypriots, male or female born between 1st January, 1932, and 1st January, 1944, within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Paphos or the Superintendent of Police in charge of the area:

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force, or other than Greek Cypriots.

3. This Order shall come into force on the 9th October, 1958.

FIRST SCHEDULE.

Within the Town Boundaries of Ktima and Kato Paphos.

SECOND SCHEDULE.

From 1800 hours on 9th October, 1958, until 0600 hours daily, until further notice.
