ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement to 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Paphos District) (No. 48) Order, 1958.

2. No Greek Cypriots, male and female born between 1st January, 1932, and 1st January, 1944, within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Paphos or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force or to other than Greek Cypriots.

This Order shall come into force on the 13th day of October, 1958.

FIRST SCHEDULE.

Within the Town boundaries of Kúma and Kato Paphos.

SECOND SCHEDULE.

From 1700 hours on 13th October, 1958, until 0500 hours daily, until further notice.

No Greek Cypriot male born between the 2nd October, 1933 and 2nd October, 1943, both dates inclusive, shall be out of doors within the area prescribed in the First Schedule hereto, between the hours prescribed in the Second Schedule hereto, except under the authority of a written permit granted by the Commissioner of Larnaca or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force or persons holding a summons to appear before a Special Court, established under the Special Courts Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons.

This Order shall come into force on the 2nd day of October, 1958.
