Order made by the Governor under Defence Regulation 64.

Whereas by Order dated the 2nd November, 1956, and published in Supplement No. 3 to the Gazette of the 24th January, 1957, under Notification No. 66 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Paleometokho Village, Nicosia District, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months;
