ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 2nd November, 1956, and published in Supplement No. 3 to the *Gazette* of the 24th January, 1957, under Notification No. 66 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Palcometokho Village, Nicosia District, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 497, 964 and 264 published in Supplement No. 3 to the *Gazettes* of the 2nd May, 1957, 31st October, 1957, and 24th April, 1958, respectively, the Order was extended for further periods of six months up to the 1st November, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
