ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Limassol District) (No. 22) Order, 1958.

2. No Greek Cypriot male or female born between the 1st January, 1932, and the 1st January, 1944, both days inclusive, shall be out of doors within the area prescribed in the First Schedule hereto, between the hours prescribed in the Second Schedule hereto, except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

3. This Order shall come into force on the 14th day of October, 1958, and shall remain in force until further notice.

Within the Municipal Boundaries of Limassol.

SECOND SCHEDULE.

From 1800 hours until 0730 hours.

1. This Order may be cited as the Curfews (Paphos District) (No. 49) Order, 1958.

2. No Greek Cypriot, within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Paphos or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

3. This Order shall come into force on the 18th day of October, 1958.

Within the Town boundaries of Ktima and Kato Paphos.

SECOND SCHEDULE.

From 0430 hours on 18th October, 1958, until 0430 hours on 19th October, 1958.
