2. No Greek Cypriot within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Paphos or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

3. This Order shall come into force on the 21st day of October, 1958.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the Gazette of 19th July, 1956, I do hereby order as follows :--

1. This Order may be cited as the Curfews (Larnaca District) (No. 18) Order, 1958.

2. No Greek Cypriot male or female born between the 1st January, 1932, and the 1st January, 1944, both dates inclusive, shall be out of doors within the area prescribed in the First Schedule hereto between the hours prescribed in the Second Schedule hereto, except under the authority of a written permit granted by the Commissioner of Larnaca or the Superintendent of Police in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force on duty, or persons holding a summons to appear before a Special Court, established under the Special Courts Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons.

3. This Order shall come into force on the 16th day of October, 1958.

4. The Curfews (Larnaca District) (No. 17) Order, 1958, dated the 14th day of October, 1958, is hereby revoked.
