**No. 949. THE MUNICIPAL CORPORATIONS LAW.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF
FAMAGUSTA.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Famagusta hereby make the following bye-laws:—

1. These bye-laws may be cited as the Famagusta Municipal (Amendment) Bye-laws, 1958, and shall be read as one with the Famagusta Municipal Bye-laws, 1940 to 1957 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Famagusta Municipal Bye-laws, 1940 to 1958.

2. Bye-law 1 (a) of the principal Bye-laws (as set out in Notification No. 40 of *Gazette* No. 2811, Supplement No. 3 of 7th February, 1940, and Notification No. 523 of *Gazette* No. 3776, Supplement No. 3 of 19th August, 1954) is hereby amended—

(a) by the deletion therefrom of the definitions "Carcass", "Meat" and "Pork" and the substitution therefor of the following definitions:—

"'Carcass' means the carcass of an animal or poultry and includes any part of any such animal or poultry;

'Meat' or 'Fresh Meat' means the meat of any animal or poultry whether fresh, frozen, raw, boiled, fried, roasted or otherwise cooked or preserved but does not include meat preserved in tins or other receptacles;

'Pork' or 'Fresh Pork' includes any pork whether fresh, frozen, raw, boiled, fried, roasted or otherwise cooked or otherwise preserved but does not include pork preserved in tins or other receptacles"; and

(b) by the insertion of the following new definition immediately after the definition of "Foreshore":—

" 'Fish' or 'Fresh Fish' means fish, whether fresh or frozen or otherwise preserved but does not include fish preserved in tins or other receptacles."

3. Paragraph (1) of bye-law 25 of the principal Bye-laws (as set out in Notification No. 40, *Gazette* No. 2811, Supplement No. 3 of 7th February, 1940 and Notification No. 457, *Gazette* No. 3844, Supplement No. 3 of 28th July, 1955) is hereby amended by the insertion therein immediately after sub-paragraph (d) of the following sub-paragraph :—

"(e) For every carcass of any poultry 25 mils per oke."

4. The principal Bye-laws are hereby amended by the insertion therein immediately after bye-law 56 (as set out in Notification No. 40, *Gazette* No. 2811, Supplement No. 3 of 7th February, 1940) of the following new bye-law :—

"56A. No person shall sell or expose for sale meat, pork, fish or poultry outside the meat markets, the pork markets or the fish markets respectively :

Provided that the Council may grant for such period and on such terms as it may see fit a permit to any person to sell or expose for sale in any specified premises in or outside the markets any meat, pork, fish or poultry and may revoke such permit at any time after giving notice in writing of thirty days to the person in the name of whom the permit was issued."

5. Paragraph (1) of bye-law 133 of the principal Bye-laws (as set out in Notification No. 40, *Gazette* No. 2811, Supplement No. 3 of the 7th February, 1940, in Notification No. 140, *Gazette* No. 3304, Supplement No. 3 of 8th May, 1947, and in Notification No. 457, *Gazette* No. 3844, Supplement No. 3 of 28th July, 1955) is hereby amended by the insertion therein immediately after sub-paragraph (d) of the following sub-paragraph :—

"(e) For every poultry 25 mils per oke of the carcass".

6. The principal Bye-laws are hereby amended by the deletion of the fees of items Nos. 57, 58, 59 and 60 of the Third Schedule (as set out in Notification No. 231, *Gazette* No. 3124, Supplement No. 3 of 3rd July, 1944, Notification No. 378, *Gazette* No. 3274, Supplement No. 3 of 21st November, 1946, Notification No. 549, *Gazette* No. 3582, Supplement No. 3 of 24th October, 1951, Notification No. 523, *Gazette* No. 3776, Supplement No. 3 of 19th August, 1954 and Notification No. 457, *Gazette* No. 3844, Supplement No. 3 of 28th July, 1955) and the substitution therefor of the following fees :—

"Item

57.	Lemons	100	3 mils for every 100 pieces
58.	Oranges (Jaffa Type)	100	5 mils for every 100 pieces
59.	Oranges (Other Kinds) and grape fruit	100	5 mils for every 100 pieces
60.	Mandarines	100	3 mils for every 100 pieces."

The above Bye-laws have been approved by His Excellency the Governor. (M.P. 1961/49/2.)
