

No. 971. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 5) 1958.

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Paphos, do hereby make the following Order :—

1. This Order may be cited as the Paphos District (Control of Motor Cycles) (No. 1) Order, 1958.

2. The use or circulation of any motor cycle by youths born on or after the 1st August, 1931, within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the Officer in charge of Paphos Police Division :

Provided that this paragraph shall not apply to :—

(a) members of Her Majesty's Forces ;

(b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.

3. No motor cycle shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.

4. This Order shall come into force at 0500 hours on the 9th November, 1958.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1958.

ORDER MADE UNDER REGULATION 60A.

Whereas I consider it expedient in the interests of public safety to make a clearance order in respect of the land described in the Schedule hereto :

Now, therefore, I, the Assistant Commissioner of Kyrenia, in exercise of the powers vested in me by Regulation 60A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Clearance) (Kyrenia District) (No. 2) Order, 1958.

2. The owners and occupiers of the land described in the Schedule hereto (hereinafter referred to as "the land"), and the agents of such owners and occupiers, are hereby directed—

(a) to cut down and clear away from the land two fig trees and a cane plantation ;

(b) to prevent any herbage, bush or undergrowth on the land from growing higher than one foot and to maintain the land in a clear condition to the satisfaction of the Area Commander, Kyrenia.
