ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666, published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District) (No. 69) Order, 1958.

2. No Greek Cypriot male or female born between the 1st January, 1932, and the 1st January, 1944, both dates inclusive, shall be out of doors within the area prescribed in the First Schedule hereto between the hours prescribed in the Second Schedule hereto, except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force on duty, persons holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons.

3. This Order shall come into force at 0800 hours on the 8th November, 1958.

FIRST SCHEDULE.

The Municipal area of Nicosia and the Improvement Board areas of Strovolos, Ayios Dhometios, Kaimakli and Palouriotissa, the village areas of Trakhonas, Omorphita, Engomi, Orta Keuy and Eylenja.

SECOND SCHEDULE.

From 0800 hours on the 8th November, 1958 to 0900 hours on the 8th November, 1958, and thence daily, excluding Sundays, until further notice.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District) (No. 70) Order, 1958.

2. No Greek Cypriot male born between the 1st January, 1932, and 1st January, 1944, both dates inclusive, shall be out of doors within the area prescribed in the First Schedule hereto, between the hours prescribed

in the Second Schedule, except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force (which term for the purposes of this Order includes the Auxiliary Police Force and the Police Fire Service) and any Special Constable when on duty as such, persons holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons, any advocate in possession of a certificate issued by a Justice of the Special Court or by the Registrar of the Special Court, Nicosia, that he is briefed to appear in the Special Court on a specified date when such advocate is proceeding to and from such Court on such date.

3. This Order shall come into force at 0500 hours on the 8th November, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

3. This Order shall come into force on the 29th September, 1958.
