

No. 992. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 9th August, 1956, and published in Supplement No. 3 to the *Gazette* of the 10th August, 1956, under Notification No. 767 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in Ibrahim Pasha Quarter, Nicosia, and Trakhonas Village, Nicosia District, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 74, 748 and 66 published in Supplement No. 3 to the *Gazettes* of the 31st January, 1957, 1st August, 1957 and 6th February, 1958, respectively, the Order was extended for further periods of six months up to the 8th August, 1958 ;
