

**No. 998. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 25th February, 1956, and published in Supplement No. 3 to the *Gazette* of the 8th March, 1956, under Notification No. 161 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Kakopetria (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 1165, 73, 744 and 60 published in Supplement No. 3 to the *Gazettes* of the 29th November, 1956, 31st January, 1957, 1st August, 1957 and 6th February, 1958, respectively, the Order was extended for further periods of six months up to the 24th August, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 25th August, 1958.

Whereas by Order dated the 27th February, 1956, and published in Supplement No. 3 to the *Gazette* of the 18th March, 1956, under Notification No. 153 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Perivolia, (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 825, 122, 743 and 57 published in Supplement No. 3 to the *Gazettes* of the 30th August, 1956, 14th February, 1957, 1st August, 1957 and 6th February, 1958, respectively, the Order was extended for further periods of six months up to the 26th August, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months ;
