PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Law, the persons whose names appear in the Schedule hereto have applied for permits under the provisions of the said Law :

And whereas the said persons have severally given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus and, while carefully abstaining from participation in political affairs, that they desire and purpose *ex animo* to work in friendly co-operation with the said Government in all matters in which their influence might properly be exerted ; and, they have undertaken that, if engaged in educational work, their influence will be exerted to promote loyalty to the Government of Cyprus in the minds of their pupils and to make them good citizens of the British Empire :

Now, therefore, in exercise of the powers vested in him by section 8 of the Missionary, Educational and Medical (Alien Regulation) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to grant to the persons whose names appear in the Schedule hereto a permit respectively to commence or carry on the work set down after their respective names.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 5) 1958.

ORDER UNDER REGULATION 38.

I, the Commissioner of Nicosia, in exercise of the powers vested in me by paragraph (1) of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, do hereby order as follows :—

1. This Order may be cited as the Protected Areas (Nicosia District No. 1) Order, 1959.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purpose of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958.

3. This Order shall come into force at 1200 hours on the fourth day of February, 1959, and shall remain in force until further notice.

SCHEDULE.

The area of Wolseley Barracks Nicosia, comprising :

- (a) Plot 86 of Block B, Ayios Andreas Quarter, Sheets XXI.46.1.IV, XXI.46.4.II, XXI.46.2.III and XXI.46.5.I of the Government Survey Plan.
- (b) Plot 52 of Block B, Ayios Andreas Quarter, Sheet XXI.46.1.IV of the Government Survey Plan.
- (c) All plots of Block B, Ayios Andreas Quarter, Sheets XXI.46.1.IV, XXI.46.4.II, XXI.46.2.III and XXI.46.5.I of the Government Survey Plan enclosed within the boundary delimited by War Department beacons 1 to 50 together with plots 61/2 and 62.

THE CURFEWS LAWS, 1955.
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Public Instrument No. 666 of 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District) (No. 1) Order, 1959.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force (which term for the purposes of this Order includes the Auxiliary Police Force and the Police Fire Service) and any Special Constable when on duty as such, persons holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons, any advocate in possession of a certificate issued by a Justice of the Special Court or by the Registrar of the Special Court, Nicosia, that he is briefed to appear in the Special Court on a specified date when such advocate is proceeding to and from such Court on such date.

3. This Order shall come into force at 0615 hours on the 23rd January, 1959.
