ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTION 23.

In exercise of the powers vested in me by section 23 of the Exchange Control Laws, 1952 to 1957, I, the Financial Secretary, do hereby make the following order :—

1. This Order may be cited as the Exchange Control (Import and Export) (Amendment) Order, 1959, and shall be read as one with the Exchange Control (Import and Export) Order, 1953 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Exchange Control (Import and Export) Orders, 1953 and 1959.

2. Sub-paragraph (a) of paragraph 3 of the principal Order is hereby revoked and replaced by the following sub-paragraph :—

"(a) on the person of or in the baggage of a traveller to the Colony in any ship or aircraft from some place outside the Colony of notes of a class which are or have at any time been legal tender in the United Kingdom or any part of the United Kingdom not exceeding £10 sterling in value."

NOTICE UNDER SECTION 2.

In exercise of the powers vested in him by Section 2 of the Bombardment Range Areas Law, as contained in the Bombardment Range Areas (Amendment) Law, 1951, His Excellency the Governor is pleased to declare the area set out in the Schedule hereto to be a Bombardment Range Area for the use of Her Majesty's Forces for a period of 12 calendar months from the date of this Notice, and is further pleased to declare that the said area shall be a practice area for the use of all kinds of small arms and the ammunition therefor ;

SCHEDULE.

" Sotira " *weapon and snap shooting range.*

All the part of the bed of the River Symvoulos situated near the locality " Kambi Tou Gelasi " in the village of Sotira, the boundary of which is marked more particularly on the ground by Danger Notices situated at prominent points warning all persons in English, Greek and Turkish to keep away from the Danger Area when red flags (or red lights by night) are displayed, and on the Government Survey Plan Serial No. 1724 by the area coloured red. A copy of the said plan has been deposited in the office of the Commissioner, Limassol.
