NOTICE UNDER SECTION 2.

In exercise of the powers vested in him by Section 2 of the Bombardment Range Areas Law, as contained in the Bombardment Range Areas (Amendment) Law, 1951, His Excellency the Governor is pleased to declare the area set out in the Schedule hereto to be a Bombardment Range Area for the use of Her Majesty's Forces for a period of 12 calendar months from the date of this Notice, and is further pleased to declare that the said area shall be a practice area for the use of all kinds of small arms and the ammunition therefor ;

SCHEDULE.

Pyroi weapon and snap shooting range.

All that area of land situated at the locality " Kastros " in the village of Pyroi, forming parts of plots Nos. 14 (the Village Fuel Area of Pyroi village) and 11 of the Government Survey Plan No. XXXI.43, the boundary of which is marked more particularly on the ground by Danger Notices situated at prominent points warning all persons in English, Greek and Turkish to keep away from the Danger Area when red flags (or red lights by night) are displayed, and on the Government Survey Plan Serial No. 1726, by the line edged in red. A copy of the said plan has been deposited in the Nicosia office of the Commissioner, Nicosia and Kyrenia.
