**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 6) 1958.**

ORDER MADE UNDER REGULATION 44.

Whereas it is expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorise its use in the interest of public order and safety :

Now, therefore, in exercise of the powers conferred upon me by Regulation 44 of the Emergency Powers (Public Safety and Order) Regulations 1955 to (No. 6) 1958, I, the Commissioner, Famagusta, hereby take possession of the land and, in connection with the taking possession and making use of the land, direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorised to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise is hereby prohibited.

SCHEDULE.

The right to 2,000 gallons of water daily from the domestic water supply of the Improvement Board of Asha village.
