Bye-laws made by the Municipal Corporation of Lefka.

In exercise of the powers vested in them by the Municipal Corporations Law and of every other power thereunto enabling, the Council of the Municipal Corporation of Lefka hereby make the following Bye-laws:—

- 1. These Bye-laws may be cited as the Lefka Municipal (Amendment) Bye-laws, 1959, and shall be read as one with the Lefka Municipal Bye-laws, 1958 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these Bye-laws may together be cited as the Lefka Municipal Bye-laws, 1958 and 1959.
- 2. Bye-law 103 of the principal Bye-laws is hereby amended by the insertion immediately after sub-paragraph (i) of the following sub-paragraph:—

"(j) supply himself with the town water from any public fountain by means of a rubber or any other hose or pipe".

- 3. Bye-law 107 of the principal Bye-laws is hereby amended by the insertion immediately after sub-paragraph (b) of the following sub-paragraph:—
 - "(c) suffer water to run to waste or irrigate with the water, lands, fields, gardens or trees."
- 4. The principal Bye-laws are hereby amended by the insertion therein immediately after Bye-law 107 of the following new Bye-law to be numbered 107A:—
 - "107A. The Mayor, or any other person authorized by him in that behalf, may inspect at any time, any yard, place or garden to which town water is supplied, and find out whether Bye-law 107 (c) is complied with."
- 5. Bye-law 110 (1) of the principal Bye-laws is hereby amended by the insertion therein, immediately after the word "thereof" (line two), of the following words:—
 - "or by any person using or having a right to use them".
- 6. The principal Bye-laws are hereby amended by the insertion immediately after Bye-law 110 of the following new Bye-law to be numbered 110A:—
 - "110A. Any owner or lessee of any water or any person or Committee of any Irrigation Association, having under his or their control any water running through any water channel shall not allow any water to pass into any street."
 - 7. Bye-law 111 of the principal Bye-laws is hereby amended as follows :-
 - (a) By the re-numbering of sub-paragraphs (3) and (4) to read (2) and (3), respectively.
 - (b) By the insertion therein immediately after sub-paragraph (3) of the following sub-paragraph:—
 - "(4) If any person does not comply with Bye-law III (3) the Mayor or any other person authorized in that behalf, may discontinue the supply of the town water."
- 8. The Fourth Schedule to the principal Bye-laws is hereby amended by the insertion therein of the following streets:—
 - "5. George the VIth Street with 'No Entry' from the Xeros-Lefka main road.

- 6. Salib Subhi Street with 'No Entry' from Marathassa-Lefka road.
- 7. Mehmed Saib Street with 'No Entry' from George the VIth Street.
- 8, Hadji Emir Street with 'No Entry' from Montagu Street".
- I, John Edward Stevenson Browne, O.B.E., Chief Constable, hereby give my concurrence to the making of Bye-law 8 of these Bye-laws.

No. 146. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW. CAP. 311.

The following Bye-laws made by the Village Water Commission of Elea in the District of Nicosia, and approved by the Commissioner, are published in the Gazette.

Bye-laws made by the Village Water Commission of Elea under SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, Cap. 311, the Water Commission of Elea village, hereby make the following Bye-laws:-

1. These Bye-laws may be cited as the Village Domestic Water Supply (Elea) (Amendment) Bye-laws, 1959, and shall be read as one with the Village Domestic Water Supply (Elea) Bye-laws, 1950 (hereinafter referred to as P.I.: "the principal Bye-laws") and the principal Bye-laws and these Bye-laws may together be cited as the Village Domestic Water Supply (Elea) Bye-laws, 1950 to 1959.

2. Rule 12 of the principal Bye-laws is hereby amended by the deletion therefrom of the words "ten shillings" and the substitution therefor (M.P. 2038/50.) of the words "two pounds".
