16 of 1958.**GROUPING OF VILLAGES UNDER SECTION 3.**

In exercise of the powers vested in the Governor by section 3 of the Rural Constables Law, and duly delegated to me under Public Instrument No. 172 of 1947, I, the Administrative Secretary, on the recommendation of the Commissioner, Nicosia and Kyrenia, do hereby direct that the villages of Mansoura and Ayios Theodoros Tillirias, in the District of Nicosia, shall be united into a group for the purposes of the said Law.

And I also direct that the Mukhtar of the Village Commission of Ayios Theodoros Tillirias shall be the Mukhtar of the Group Commission for all the purposes of the said Law.

2. Public Instrument No. 73 of 1933 is hereby amended by the deletion therefrom of item 11 appearing under the heading "Nicosia District".

(CYPRUS) ORDER, 1946.****ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.**

Whereas by Order dated the 16th March, 1956, and published under Public Instrument No. 217 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorized the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the villages of Kato and Pano Lakatamia (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 969 of 1956, 219 of 1957, 820 of 1957, 163 of 1958 and 1008 of 1958, the Order was extended for further periods of six months up to the 15th March, 1959 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 16th March, 1959.
