Whereas by Order dated the 3rd September, 1956, and published under Public Instrument No. 851 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorized the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Ayios Theodoros village, Famagusta District (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months;

And whereas by virtue of Public Instruments Nos. 220 of 1957, 814 of 1957, 166 of 1958 and 1002 of 1958, the Order was extended for further periods of six months up to the 2nd March, 1959;
