

**No. 188. THE CONTAGIOUS DISEASES (ANIMALS) LAW.**  
(CAP. 65).

**ORDER UNDER SECTION 4.**

In exercise of the powers vested in the Governor by sub-section (1) of section 4 of the Contagious Diseases (Animals) Law and delegated by His Excellency to the Director of Agriculture on the 6th day of February, 1959, which delegation relates to orders made for the purpose of controlling contagious diseases among poultry, I, the Director of Agriculture, hereby make the following order :—

1. This Order may be cited as the Contagious Diseases (Poultry) Order, 1959.

2. Every—

- (a) owner or operator of a hatchery having an Incubator or Incubators of a total egg capacity of 1000 eggs and above, for the purpose of producing and selling day-old chicks ;
- (b) owner of 100 hens or pullets keeping them for the production of hatching eggs for his own use in, or for sale to, a hatchery of the size stated above ; and
- (c) person who is involved in the import of day-old chicks for the purpose of rearing them personally or for selling them to other persons,

shall register his name and address and furnish relevant particulars before the 1st of May, 1959, on the forms set out in the Schedule hereto.

3. Any person who fails to register under this order shall be liable, on conviction, to a fine not exceeding £10.
