THE EMERGENCY POWERS ORDERS IN COUNCIL, 1939 AND 1956.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

HUGH FOOT,

Governor.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1956, I, the Governor, do hereby make the following Regulations :-

1.-(1) These Regulations may be cited as the Emergency Powers (Revocation of Certain Emergency Regulations) Regulations, 1959.

(2) The Interpretation Law shall apply to the interpretation of these Cap. 1 Regulations as it applies to the interpretation of a Law, and, for the purposes 30 of 1953 19 of 1954 30 of 1954 of the said Law, these Regulations shall be deemed to be Laws.

2. The Regulations set out in the Schedule to this Order are hereby 42 of 1955 about 19 of 1955. revoked.
