THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 6) 1958.

REVOCATION OF ORDER MADE UNDER REGULATION 44.

THE PUBLIC HEALTH (VILLAGES) LAW.  
CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF  
GEUNYELI UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Geunyeli hereby make the following rules :—

1. These rules may be cited as the Village Health (Geunyeli) (Amendment) Rules, 1959, and shall be read as one with the Village Health (Geunyeli) Rules, 1954 (hereinafter referred to as "the principal Rules") and the principal Rules and these Rules may together be cited as the Village Health (Geunyeli) Rules, 1954 and 1959.

2. Rule 19 of the principal Rules is hereby repealed and substituted by the following rule :—

"Rule 19. The following fees shall be paid by the owner of or the person slaughtering any animal in a slaughter-house, that is to say :—

| (b) for every goat, kid, lamb or sheep—       |               |

3. Rule 45 of the principal Rules is hereby repealed and substituted by the following rule :—

"Rule 45.—(1) The following fees shall be paid by every person exposing for sale any fresh meat in the meat market, that is to say :—

| (a) for every carcass of sheep or goat or part thereof   | £0.050 mils. |
| (b) for every carcass of a young lamb or kid or part thereof (not exceeding 6 okes in weight) ... .. | £0.025 mils. |
| (c) for every carcass of ox, camel, cow or bullock or part thereof ... ..                            | £0.150 mils. |

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing for sale any fresh meat in the meat market, who is a monthly or a weekly lessee of any shop, stall or place in the meat market under Rule 45 of these Rules."
