THE EMERGENCY POWERS ORDERS IN COUNCIL, 1939 AND 1956.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1956, I, the Governor, do hereby make the following Regulations:—

P.I. 731/1955 to P.I. 130/1959. 1. These Regulations may be cited as the Emergency Powers (Public Safety and Order) (Amendment) (No. 2) Regulations, 1959, and shall be read as one with the Emergency Powers (Public Safety and Order) Regulations, 1955 to 1959 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 2) 1959.

Amendment to Regulation 3 of the principal Regulations.

Revocation of certain Regulations of the principal Regulations.

- Amendment to Regulation 2. Paragraph (2) of Regulation 3 of the principal Regulations is hereby amended by deleting the words "twenty-eight days" which occur in the last line thereof and substituting therefor the words "forty-eight hours".
 - 3. The principal Regulations are hereby amended by the revocation of the Regulations specified in the Schedule hereto without prejudice to anything done or omitted to be done thereunder.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64-

Whereas by Order dated the 18th October, 1955, and published under Public Instrument No. 634 of 1955 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Katholiki Quarter, Limassol (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months;
