

**No. 208. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 19th October, 1955, and published under Public Instrument No. 638 of 1955 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Pano Platres (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 297 of 1956, 1164 of 1956, 393 of 1957, 907 of 1957, 226 of 1958 and 798 of 1958, the Order was extended for further periods of six months up to the 18th April, 1959 :

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorised the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of one month as from the 19th April, 1959.

**No. 209. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 11th April, 1956, and published under Public Instrument No. 307 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Chiftlikoudhia Quarter, Limassol Town (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 1165 of 1956, 400 of 1957, 902 of 1957, 215 of 1958 and 1016 of 1958, the Order was extended for further periods of six months up to the 10th April, 1959 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorised the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 11th April, 1959.
