# CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

### Notice under Section 6.

With reference to Public Instrument No. 30 of 1953, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein:—

All those areas of privately-owned lands, with everything standing thereon, situated at Evdhimou village, comprising 12 donums or thereabouts, forming parts of plots Nos. 96, 100, 101, 102, 104, 105, 106, 107, 109, 124, 131/1, 125, 126, 127 and 128 of the Government Survey Plan No. LII. 64, parts of plots Nos. 160, 163, 164, 162, 165/2, 169, 156/1, 170, 134, 172, 133/1, 173, 125, 126, 122, 121, 118, 119, 60, 61, 55, 68, 69, 53 and 54 of the Government Survey Plan No. LVII. 8, more particularly defined as the areas coloured red on the plan signed by the Assistant Director of Lands, Cyprus, dated the 23rd February, 1959.

Any person claiming to have any right or interest in the said lands who objects to the acquisition is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. Her Majesty's Secretary of State for War is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office.

### THE POLICE LAW, 1958.

In exercise of the powers vested in me by section 10 of the Police Law, 1958, I, the Chief Constable, with the approval of the Governor, do hereby make the following Regulations : —

1. These Regulations may be cited as the Police (General) (Amendment) Regulations, 1958, and shall be read as one with the Police (General) Regulations, 1958 (hereinafter referred to as "the principal Regulations").

2. Regulation 11 of the principal Regulations is hereby amended by deleting the words "in the case of Gazetted Officers" which occur in proviso (a) of paragraph (1) thereof and by substituting therefor the word "all".

3. Regulation 30 of the principal Regulations is hereby amended by deleting the figures "28" which occur in the last line of paragraph (3) thereof and by substituting therefor the figures "29".

4. The Second Schedule to the principal Regulations is hereby amended by deleting the figures "13" where they appear in the column headed "On asphalt roads" and by substituting therefor the figures "17".
