THE CYPRUS INLAND TELECOMMUNICATIONS (STOCK) REGULATIONS,
1958.

(P.I. No. 1095 OF 1958.)

Whereas under the provisions of section 14 of the Inland Telecommunications Service Law, 1954, the Cyprus Inland Telecommunications Authority with the consent of the Governor has resolved to borrow one hundred thousand pounds on the issue of Telecommunications (Second Issue) Stock, 1963, pursuant to section 15 of the said Law and as hereinafter provided :

Now, therefore, in exercise of the powers conferred upon him by paragraph (1) of Regulation 3 of the Cyprus Inland Telecommunications (Stock) Regulations, 1958, the Governor hereby amends the Schedule to the said Regulations to provide for an additional issue of stock by adding at the end thereof the new item following :—

“ Designation of Stock	Amount	Rate of interest per annum	Date of Redemption
Telecommunications (Second Issue) Stock, 1963.	£100,000	3%	1st January, 1963 31st December, 1963.”

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 19th October, 1955, and published under Public Instrument No. 637 of 1955 (hereinafter referred to as “the Order”), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Pedhoulas village in the District of Nicosia (hereinafter referred to as “the land”), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 294 of 1956, 1164 of 1956, 392 of 1957, 914 of 1957, 228 of 1958 and 794 of 1958, the Order was extended for further periods of six months up to the 18th April, 1959.

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorised the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 19th April, 1959.

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 27th April, 1956, and published under Public Instrument No. 363 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Lapithos (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 1165 of 1956, 400 of 1957, 909 of 1957, 220 of 1958 and 799 of 1958 the Order was extended for further periods of six months up to the 26th April, 1959.

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorised the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 27th April, 1959.
