

No. 229.**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 24th April, 1956, and published under Public Instrument No. 332 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Ayia Phyla (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 1165 of 1956, 400 of 1957, 903 of 1957, 217 of 1958 and 792 of 1958 the Order was extended for further periods of six months up to the 23rd April, 1959.

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
